- 1. To act as a body, to whom any student of the Institute, Parent or anyone else having any kind of grievance can approach for its redressal.
- 2. The Grievance Redressal Committee shall brief the aggrieved part at the commencement of every semester about its composition and tasks. The aggrieved party shall also be asked to approach the said committee in case of any kind of grievance.
- 3. On receipt of any grievance, the committee shall go into the causes and find the quickest possible remedy.
- 4. The decision of the committee shall be communicated to the aggrieved party and if the aggrieved party is satisfied, the matter shall be treated as closed.
- 5. If the aggrieved party is not satisfied, then the cause shall be brought to the notice of the Ombudsman for the review and resolution of the matter.
- 6. The decision given by the Ombudsman of Institute shall be binding both on the aggrieved party as well as on the Institute. However, the privilege to appeal the issue to any of the higher judicial authorities shall remain open to both the parties.

- b) Provide Mechanism of dispute redressal and dialogue to anticipate and address issues through just and fair conciliation without undermining complaint's rights and minimize the need for purely punitive approaches that lead to further resentment, allentation or violence.
- c) Protect the safety of the complaints by not divulging the person's identity, and provide the mandatory relief by way of sanctioned leave or relaxation of attendance requirement or transfer to another department or supervisor as required during the pendency of the complaint, or also provide for the transfer of the offender;
- d) Ensure that victims or witnesses are not victimized or discriminated against while dealing complaints of sexual harassment; and with
- e) Ensure Prohibition of retaliation or adverse action against a covered individual because the employee or the student is engaged in protected activity.
